unitization of the East Gilbertown Eutaw Unit consisting of the Southeast Quarter and the East Half of the Southwest Quarter of Section 1, Township 10 North, Range 3 West, and the Southwest Quarter of the Southwest Quarter of Section 6, Township 10 North, Range 3 West, all in Choctaw County, Alabama, in the Gilbertown Oil Field.
